Geoff quote \$1600 for storage lockup will hold TV and iPads. Nominated by Geoff Seconded by Alex

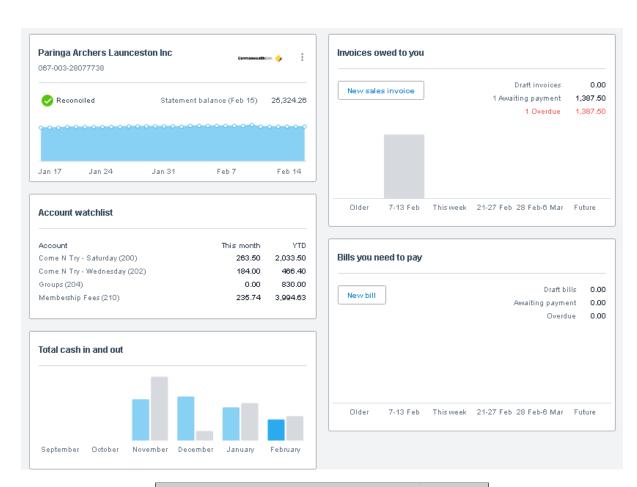

Dear Dean,

The committee has discussed your email and agreed on the following.

The subject of your email should have been "Committee minutes", as these are the minutes you are referring to.

Within your first point you have asked what EOI stands for, this is an acronym that standards for "expressions of interest" in this case there were three expressions of interest for the position.

To answer your second point, the Executive committee made a decision, in the interest of the club, which was then reported to the committee.

A quorum was achieved based on the attendance of the ordinary committee members, who were elected at the 2020 AGM. The Club Recorder, President, Secretary, Treasurer, Coaching Coordinator and Public Relations were in attendance.
