Members are to be asked if anyone is willing to climb onto the roof to silicon around the edges in an attempt to stop leakage. As well the Club will purchase a sign warning of the wet floor and also an amount of plastic Duck Board to prevent anyone slipping. This is an interim measure.

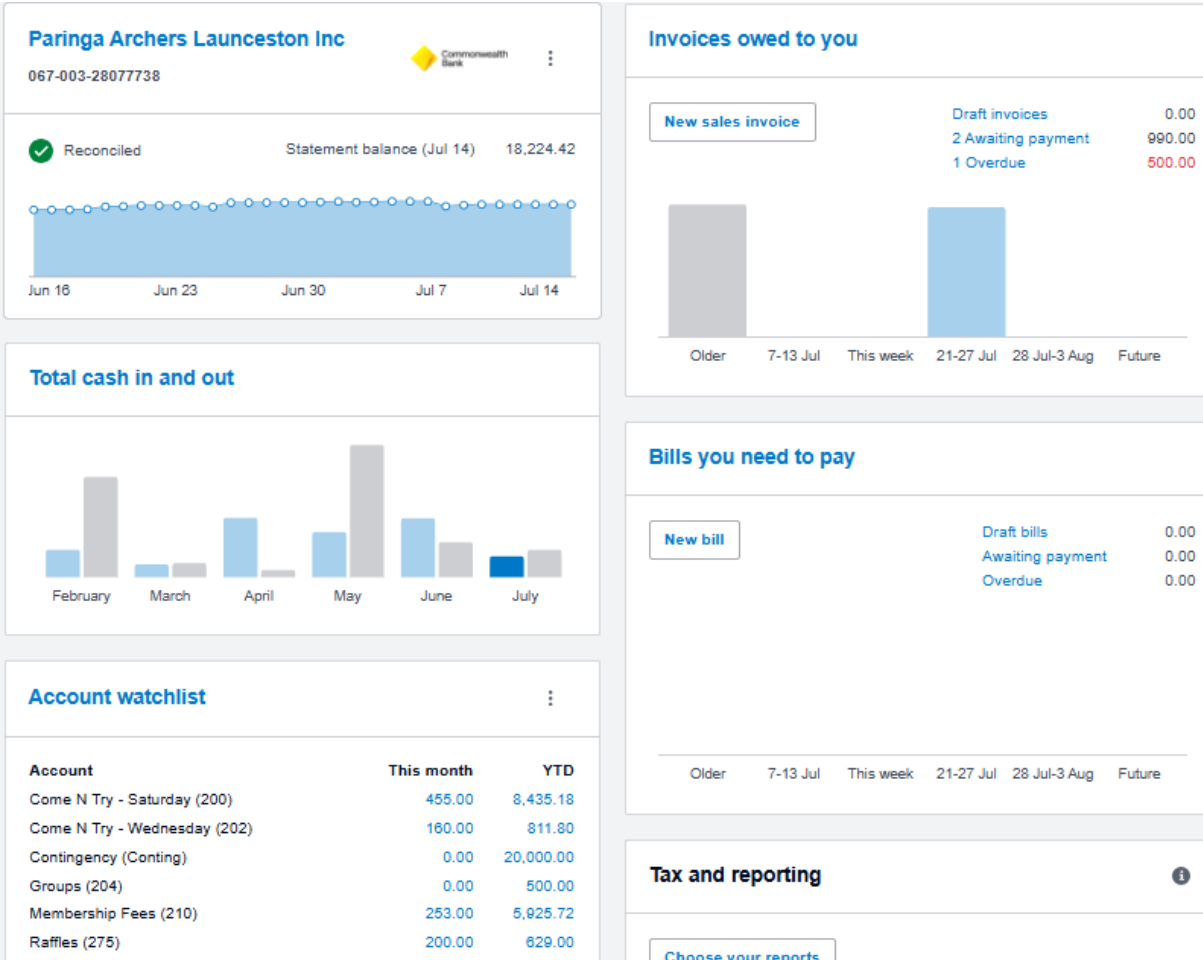
