- (8) WORKING BEE. This will be held on 3<sup>rd</sup> November, 2024.

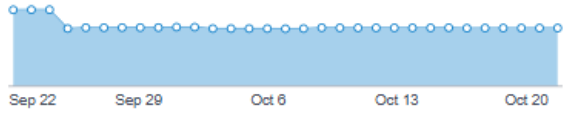

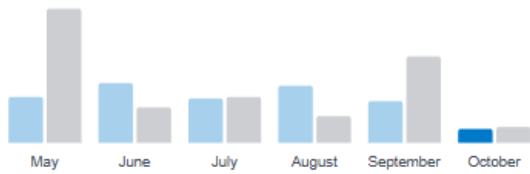
